

International Sales Agreement

This agreement is between Gustavo Barrera Belloc (hereinafter referred to as The Breeder) and the person described on Part B of this agreement (hereinafter referred to as The Buyer)

Part A - Terms and Conditions of Sale

- 1.- To reserve a puppy the buyer shall complete Part B of this agreement and fax it to the breeder. The buyer shall pay to the breeder the first half of the total price of the puppy as a way of deposit.
- 2.- Upon the happening of the events described in clause 1 above, the breeder shall complete Part C of this agreement and fax it to the buyer.
- 3.- The selection process will start 6 weeks after the date of birth of the puppies. The buyer shall indicate the puppy of his/her choice in accordance to his/her position on the reservation list.
- 4.- Upon the happening of the events described in clause 3 above, the buyer shall pay to the breeder the second half of the price of the puppy.
- 5.- It is the entire responsibility of the buyer to complete any course of vaccinations commenced by the breeder, including any upgrade or repetition of any vaccine as deemed to be necessary by a licensed veterinary.
- 6.- In the event that a genetic or hereditary disease arises and which is sufficiently serious in the opinion of two qualified veterinarians, one of whom selected by the breeder, then the breeder will replace the puppy/dog subject of this agreement with a puppy from the next available litter, provided that the puppy/dog subject of this agreement has never been used for breeding and has not been subject to an accident or injury.
- 7.- In order to qualify for a replacement puppy: a) any and all documentation pertaining to the dog subject of this agreement shall be delivered to the breeder prior replacement, b) The dog subject of this agreement shall be returned to the breeder at the buyer's expense prior replacement, and c) transportation costs of the replacement puppy shall be at the buyer's expense.
- 8.- The puppy/dog subject of this agreement is not for resale. Any and all expenses incurred by the buyer are the entire responsibility of the buyer.
- 9.- The breeder guarantees the puppy/dog subject of this agreement to be in good health and free from parasites as of the time of sale. A health certificate will be issued by a licensed veterinary for such purpose.
- 10.- The buyer shall be entitled to receive a full refund of the deposit if no puppies were born or are available for sale after six months from the date of reservation, or if the puppy dies during custody of the breeder.
- 11.- The price of the puppy includes or covers the following expenses: All vaccines required to export the puppy, deworming, veterinary care up to the date of delivery, health certificate, 1 airline certified crate, air delivery fees (U.S. Only) and a notary public certified copy of the pedigree certificates of both the Father and the Mother of the puppy. Puppies are sold without registration in Mexico.
- 12.- The breeder testifies that all pedigree certificates of all stud dogs and breeding females of his property are Czech pedigree certificates, duly registered and issued by the CMKU (Ceskomoravská Kynologická Unie) and duly recognized by the FCI (Federation Cynologique Internationale). The breeder testifies that all stud dogs and breeding females of his property are pure breed German Shepherds imported from the Czech Republic, and that only Czech imported stud dogs and breeding females are used for breeding. Note: If the mother of the puppy belongs to another person (Stud Dog Service) then her place of birth and pedigree information will be stated on page 3 of this agreement.
